ISELIN DISTRICT #11 2013 ANNUAL RENEWAL AGREEMENT FOR DISPATCH

WHEREAS an interlocal agreement for dispatch services has previously been entered between Fire District #7 AND Fire District #11 both in Woodbridge Township, dated September 25, 2012; and

WHEREAS both Districts have annually renewed said Agreement and again agree to renew said Agreement for the year 2013; and

WHEREAS the parties enter into this Agreement to memorialize the annual renewal with the only change being the revised rate to be paid by District #11 to District #7;

NOW, THEREFORE, be it agreed as follows;

- 1. District #11 shall pay District #7 an annual fee of \$72,160.00 to be paid \$6,013.00 monthly on or before the first day of each month beginning January 1, 2013 with the last payment due on or before December 1, 2013.
- 2. All other provisions of the original Dispatch Agreement annually renewed to the present shall remain in full force and effect as though fully restated and set forth herein.
- 3. Approval of this Agreement shall be by Resolution of the Boards of Commissioners for the respective Fire Districts.
