NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WOODBRIDGE, that the Township accepts the aforementioned Property from Fire District #11 and authorizes the Mayor or his designee to execute a hold harmless agreement for the purchase of said Property; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer pay the sum of \$1.00 to Fire District #11 for said Property.
